 - -Eddie has the new proof of insurance form for liability. It is needed when you sell your unit.
 - -There is a raccoon and iguana problem but no inexpensive solution.
 - -Last year the pool was resurfaced, a bird deterrent was built by the pool and the pavers were cleaned and sealed.
 - -2013 Projects: Spalling Repair, moving sand to build up on the seawall.
 - -An updated directory should be available next week.
 - -The big 70° tree at Unit 13 must come down. It is hitting roofs and is a danger in a storm.
 - -The gate on the Kito property is still being worked on by the City. There are police patrols at night and day. They are walking the beach also. If there is any disturbance or homeless living on either side of Casa Caselles, you can call the Non-emergency # 809-1111.
